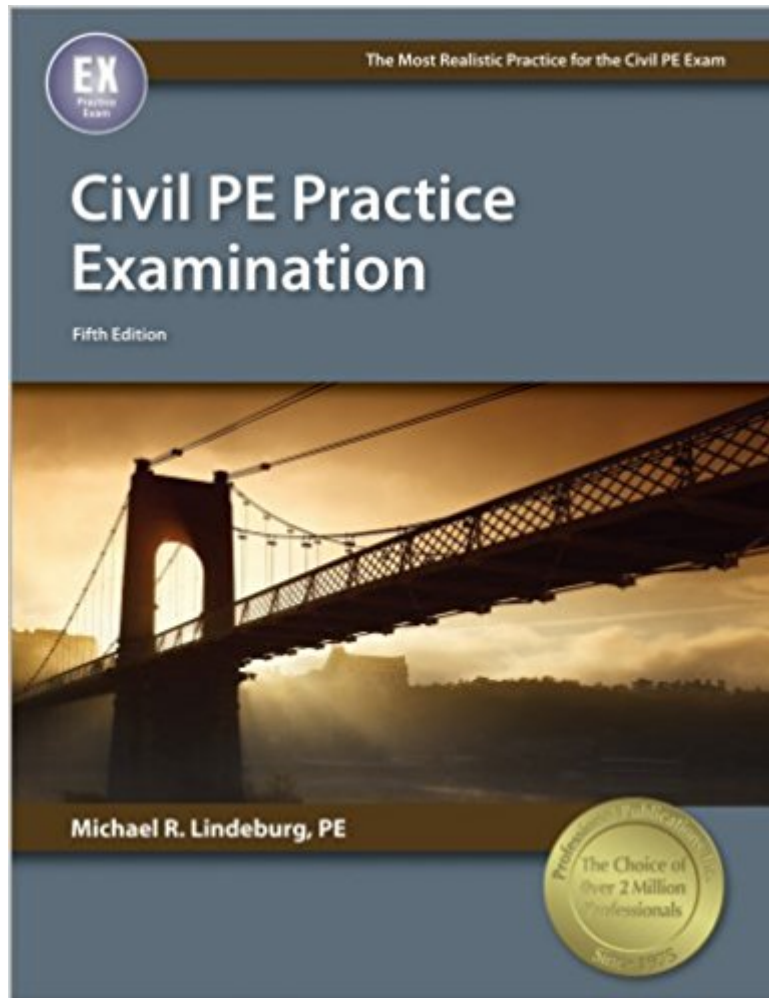

Introduction ABOUT THE PE EXAM Civil PE Practice Examination provides the opportunity to practice taking an eight-hour test similar in content and format to the Principles and Practice of Engineering (PE) examination in civil engineering. The civil PE examination is an eight-hour exam divided into a morning session and an afternoon session. The morning session is known as the "breadth" exam, and the afternoon session is known as the "depth" exam. This book contains a sample breadth module and five sample depth modules— one for each subdiscipline tested by NCEES. In the four-hour morning session, the examinee is asked to solve 40 problems from five major mechanical engineering subdisciplines: construction (approximately 20% of the exam problems); geotechnical (20%); structural (20%); transportation (20%); and water resources and environmental (20%). Morning session problems are general in nature and wide-ranging in scope. The afternoon session is also four hours. NCEES allows the examinee to select one of three depth modules (construction; geotechnical; structural; transportation; or water resources and environmental) when registering for the exam. At the exam, only the examination book- let of the depth module selected when registering for the exam will be provided. Switching modules is not possible. The answer sheet will be scored based on the module selected during registration. Each depth module is made up of 40 problems. Afternoon session problems require more specialized knowledge than those in the morning session. All problems, from both the morning and afternoon sessions, are multiple choice. They include a problem statement with all required defining information, followed by four logical choices. Only one of the four options is correct. The problems are completely independent of each other, so an incorrect choice on one problem will not carry over to subsequent problems.

WAY harder than the actual PE exam, this practice exam actually was so hard that working through the problems actually ended up hurting my confidence, which I didn't think was worth it, so I ended up putting it down and working off of other NCEES practice exams. Those were way more similar to what I encountered in the real exam!

This version is not the most up to date. This is not to the 2015 exam standard for masonry, steel and concrete.

This is not a book for reviewing. I wasn't fully aware of this, but its fine. This is just one set of practice problems. A bit expensive.

I took the breadth and the transportation depth sections of this book, and there are unfortunately a handful of reasons why i'm only giving this three stars. The most glaring reason is 1) It is out of date with the test material in that the breadth test included chemistry and water treatment questions, which are no longer part of the morning portion (the transportation section IS, however, up to date with the 2015 AASHTO revisions). 2) The breadth portion was significantly harder than the actual morning test, though it did help me feel very prepared for it. 3) The transportation portion in this book contained a great deal more in the way of calculations than the actual test did (a lot more curve geometry, etc.) however, the actual test, I felt, went light on this. Instead, the actual test included a lot more looking up basic criteria in the required manuals (HCM, AASHTO, and MUTCD), granted, that's not something you can really study for anyway, so perhaps that was intentional. Just know that it will be on the actual test. HAVE THOSE BOOKS and don't let the actual test catch you off guard when it feels like it's not following the same format. 4) I noticed what I believe was at least one error with their solutions. It should also be noted that many of the problems are taken EXACTLY from previous versions of this same book. Though things like the transportation section have been updated, older versions would still give you the same review material (minus transportation, plus even more chemistry). If you're on a tight budget and know what sections to ignore, an older version may still be helpful for you. Over all, though, it was nice to have this test and the corresponding solutions for the actual test, as I was able to look up a question or two and almost just plug and

chug with the new numbers.
