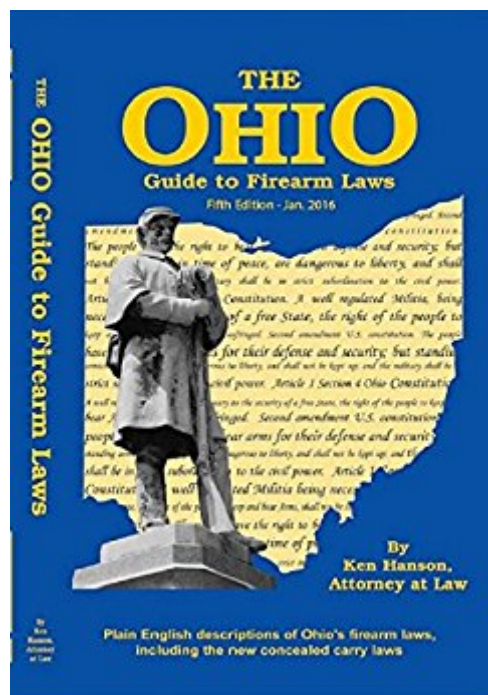

This is the definitive guide to gun law in Ohio, with an emphasis on concealed carry. I keep a copy in my office and refer to it often whenever I have a question. The Ohio Revised Code is publicly available, but it's not easy to read or understand for the layman. And the law "as applied" isn't something the average person can decipher. The author provides plain English explanations, with examples, to help gun owners understand the laws most likely to affect them and how to best comply and stay legal. I highly recommend this book.

I'm an attorney in Ohio, and this is the definitive guide to Ohio gun laws. Ohio's gun laws are confusing and non-intuitive in many ways (anyone remember the "prudent person" standard we used to have?), and if you have a CCW permit, or own a firearm for self-defense, I strongly recommend this book. It will help you avoid carrying in a situation you should not be carrying, or deploying a firearm in a situation where you are not legally justified to do so. Don't NOT buy this book.

This is a great book if you live in Ohio and are getting your conceal carry license! Ken actually came to my CCW class to speak and do a QA session as part of the class. Reading this book was as

informative and enjoyable as his lecture.
